

**PRICELIST**  
**FOR CARGO SERVICES IN CARGO CENTRE AT SKOPJE INTERNATIONAL AIRPORT**

**1. Handling services**

1.1. Handling services for cargo and mail shall be charged as per GROSS WEIGHT, as follows:

Up to 20 kg.	9, 00 EUR
From 21 to 50 kg.	12, 00 EUR
From 51 to 100 kg.	15, 00 EUR
Additionally for every 100 kg.	2, 00 EUR

1.2. Handling services for **Special shipments** – (VAL, PER, DGR, AVI, HUM, etc.), and **Diplomatic mail** (DIP).

1.2.1. Handling services for **Valuable cargo** (VAL), other than banknotes and gold, shall be charged in accordance with Item 1.1., plus:

1.2.1.1. for shipments which value ranges from 0 to 300.000.000 EUR - 0,025 % (zero point zero twenty five percent) as of the declared value of the shipment;

1.2.1.2. for shipments which value ranges from 300.000.001 to 350.000.000 EUR - 0,020 % (zero point zero twenty percent) as of the declared value of the shipment;

1.2.1.3. for shipments which value ranges from 350.000.001 to 400.000.000 EUR - 0,0175 % (zero point zero one hundred seventy five percent) as of the declared value of the shipment;

1.2.1.4. for shipments which value exceeds 400.000.000 EUR - 0,015 % (zero point zero fifteen percent) as of the declared value of the shipment;

1.2.2. Handling services for **Valuable cargo** (VAL), only for banknotes and gold, shall be charged in accordance with Item 1.1., plus additional **26,00 EUR** per shipment.

1.2.3. Handling services for **other special cargo** (perishable-PER, dangerous goods-DGR, alive animals-AVI, human remains HUM, etc.), diplomatic mail – DIP and packages heavier than 450 kg – HEA, shall be charged according to item 1.1 and additional **12,00 EUR** per shipment.

1.3. Handling services for **specialized cargo**, (specialized cargo products – Express cargo, Courier shipments, and same day delivery) and **consolidated shipments**.

1.3.1. Handling services for specialized cargo and consolidated shipments which are assorting according to House airway bills /HAWB/ shall be charged according to item 1.1.

1.3.2. Handling services for consolidated shipments /MAWB/ which are not deconsolidated by House airway bills /HAWB/, shall be charged, as follows:

Up to 100 kg. / Per kg.	0, 50 EUR
From 101 kg. to 500 kg. / Per kg.	0, 40 EUR
Over 500 kg. / Per kg.	0, 20 EUR

1.3.3. Handling services for delivered consolidated shipments /MAWB/ which are not deconsolidated by House airway bills /HWAB/, shall be charged according to following prices :

- For shipments up to 1.000 kg	40, 00 EUR
- For each additional 1.000 kg	20, 00 EUR

## **2. Storage of the cargo in warehouse**

2.1. Price for storage of the cargo in warehouse shall refer as per day and it shall be calculated as of the day of entrance of the shipment in the warehouse, as follows:

Up to 20 kg.	1, 00 EUR
From 21 kg. to 50 kg.	1. 50 EUR
From 51 kg. to 100 kg.	2. 00 EUR
Over 100 kg. / Per 1 kg.	0, 03 EUR

2.2. For rendered services for placing cargo, for which special conditions are required, in the warehouse, 100% increased price according to item 2.1 from the Price list shall be charged.

## **3. Handling the cargo outside the warehouse of the Cargo Center Department.**

3.1. Export – handling of cargo and mail from the truck to the aircraft shall be charged as follows:

- Regular handling according item 1.1
- Entrance of the truck at the Air Side shall be charged according to item 4.1

3.2. Export- for enabled export – handling of cargo and mail through staff entry shall be charged according to item 1.1 and 1.2.

- This refers only to diplomatic shipments, bank shipments and shipments which are handed over to the passenger's exit Customs control, where the passenger personally takes the shipment outside the State without Cargo Manifest.

3.3. Import – taking the cargo and mail from the aircraft at the apron shall be charged according to item 1.1 and 2.1 from the Price list.

#### 4. Handling of cargo shipments with truck at airside – (RFS and non-RFS)

4.1. Entrance of the vehicle at the apron (Air Side) in the capacity of handling of cargo and mail.

- Vehicle or pickup vehicle	30, 00 EUR
- Van	50, 00 EUR
- Truck	90, 00 EUR
- Truck with trailer	110, 00 EUR

4.2. Handling of cargo and mail with **truck – RFS:**

- Shall be charged per vehicle according to item 4.1
- For usage of equipment and manpower for loading/unloading of the vehicle it shall be charged according to items 7.18; 7.19 and 7.20.

4.3. Handling of cargo and mail with **truck at airside – non-RFS:**

- Shall be charged per shipment, depending on the usage of airport equipment
- Pricelist for cargo loading/unloading depending on the equipment used is provided below:

#### 5. Services for shipments stored in the warehouse due to unfinished customs procedures

5.1. Shipments kept from the natural persons (passengers) and stored in the Cargo Centre warehouse, services shall not be charged for the first 10 days considered as of the day of issuing the customs document/receipt, i.e. as of the day when the shipment is under customs supervision.

5.2. Shipments kept from the natural persons, but intended for use by legal entities and stored in the warehouse of Cargo Centre, services shall be charged as of the day of issuing the customs document/receipt.

## 6. Transit and transfer

6.1. Services for shipments in transit and transfer shall be charged according to items 1.1; and 1.2 per shipment.

6.2. Payment is performed from the Airline Carrier who has delivered the shipment to Skopje International Airport.

### **8.2. Prices for driving the shipments in /out of the Cargo Centre**

8.2.1. Prices for driving the shipments in / out of Cargo Centre - from / to Skopje International Airport

- I- zone – from / to Skopje

From 51 to 100 kg.	15, 00 EUR
Over 101 kg.	30, 00 EUR
- II zone – up to 100 km per shipment	65, 00 EUR
- III zone – over 100 km per shipment	130, 00 EUR

8.2.2. Prices for shipping services and services for driving the shipments from / to Skopje International Airport, after working hours as well as during national holidays shall be increased by 100 %.

## **9. Exemption from payment**

9.1. All kinds of humanitarian shipments confirmed with resolution/decision by competent authority and approved by the General Manager of TAV Macedonia DOOEL Mralino, Ilinden

9.2. Given services to the other Sectors at TAV Macedonia DOOEL Mralino, Ilinden

## **10. Shipments with term of storage**

For the shipments which are taken from the Customs after the issued terms of storage shall be charged according to items 1; 2; 5 and 7 with discount of 50 % from this Price list:

- For the services where the cargo's Air way bill has not been redeemed, this will be charged from Airline Carrier of the shipment.

- For the services where the cargo's Air way bill has been redeemed, this will be charged from consignor of the shipment, meaning the agent which has redeemed the Air way bill.

## **11. General terms**

11.1 Working hours of the Cargo Center with clients is:  
Monday – Saturday from 08.00 to 19.00 hour.

11.2. Consignor of the shipment, or his agent, shall be obligated to revise the shipment during the takeover in warehouse, and in case of possible deficiencies, such will be noted in a report together with the authorized person. Otherwise, delivered, taken over, cargo will be considered in proper order.

11.3. In case the user of the services fails to settle its obligations in terms of payment thereof, Cargo Center shall keep the right to terminate the provision of the services to the user, i.e. the shipments will be kept until the user meets his liabilities.

18% VAT shall be calculated within the prices, whenever applicable.

Domestic legal entities and natural persons shall settle the payment in cash in MKD equivalent according to the average exchange rate of the National Bank of the Republic of Macedonia on the day of provision the service or on the grounds of issued invoice in MKD equivalent according to the average exchange rate of the National Bank of the Republic of Macedonia, within 15 days as of the day of invoicing.

For foreign airline carriers, payment shall be in cash on the day of provision of the service or on the grounds of issued invoice, in Euros or any other foreign convertible currency, according to the average exchange rate of the National Bank of the Republic of Macedonia on the day of payment, within 15 days as of the day of invoicing.
