1.1.	Handling services for the acceptance and dispatch of goods and mail are charged by GROSS WEIGHT, namely:		
	- Up to 20 kg	10.00	Eur

1.2.	Handling services for acceptance and dispatch of special shipments (special shipments - VAL, PER, DGR, AVI, HUM, etc.) and diplomatic shipments (DIP).		
1.2.1.	PER, DGR, AVI, HUM, DIP, etc. - a 50% increased price is charged according to point 1.1		
1.2.1.1	HEA shipments that are oversized will be 50% increased price according to point 1.1		
1.2.2.	VAL (banknotes and gold) – 100% increased price is charged according to point 1.1		
1.2.3.	Handling services for acceptance and dispatch of valuable shipments (VAL) except for banknotes and gold are charged according to point 1.1 and additionally:		
1.2.3.1.	For shipments whose value is from 0 to 300.000.000 euros – 0.025% (zero-point zero twenty-five percent) of the declared value of the shipment

10.	Shipments with term of storage		
10.1.	For the shipments which are taken from the Customs after the issued terms of storage shall be charged according to items 1; 2; 5 and 7 with discount of 50 % from this Price list:		
	For the services where the cargo's Air Waybill has been redeemed, this will be charged from consignor of the shipment, the agent which has redeemed the Air Waybill.		
11.	General terms		
11.1.	Working hours of the Cargo Center with clients are Monday – Saturday from 08.00 to 19.00 hour.		
11.2.	Consignor of the shipment, or his agent, shall be obligated to revise the shipment during the takeover in warehouse, and in case of possible deficiencies, such will be noted in a report together with the authorized person. Otherwise, delivered, taken over, cargo will be considered in proper order.		

11.3.	In case the user of the services fails to settle its obligations in terms of payment thereof, Cargo Center shall keep the right to terminate the provision of the services to the user, i.e. the shipments will be kept until the user meets his liabilities.
11.4.	Whenever applicable 18% VAT shall be calculated within the prices, published in this Price list.
11.5.	Domestic legal entities and individuals make payment in denars equivalent value on the day of performing of the service or based on received invoice, according to the middle exchange rate of the National Bank of RNM on the day of payment, or within 15 days from the day of invoicing for legal entities that have signed an Agreement for cargo services.
11.6.	Foreign air carriers make the payment in cash on the day of the service or based on the received invoice, in euros or in any foreign convertible (effective) currency, according to the conversion rate determined by the National Bank of RNM on the day of payment, in terms provided in accordance with of the signed SGHA.
11.7.	The prices provided in this Price List are stated in Euros.
